- Inaccurate packing lists that can lead to trouble at the Customs.
- If the Bank Draft form is not filled correctly there can be a chance of your payment not arriving on time.

### 2. Wrong Classification of Goods

There stand some potentially dangerous consequences of misclassifying your goods. The misclassified filing can be rejected by the authorities or in case it is allowed to proceed, it might be seen as a case of legal fraud or subjected to some serious penalties.

#### 3. Wrong Value or Product Description

Be very careful about not creating a Product Description that does not match your Letter of Credit. The Product Description and other fields must match how the products are being described in the Letter. The Commercial Invoice should be correct and the value and other functions must be accurately mentioned.
